

## **Privacy Policy**

### **General statement**

This Privacy Policy describes our collection, use, disclosure, retention and protection of your personal information. It applies to any site where this Privacy Policy appears in the footer, and to any website, application, service, tool or agreement (collectively "Services") where this Privacy Policy is referenced, regardless of how you access or use them, including through mobile devices.

By using our Services and/or registering for any account with us, you are accepting the terms of this Privacy Policy and you are consenting to or you acknowledge our collection, use, disclosure, retention and protection of your personal information as described in this Privacy Policy. If you do not provide the information we require, we may not be able to provide all of our Services to you.

### **What does this Privacy Policy cover?**

This Privacy Policy is to inform you in scope of the use of your personal information which is collected for the purposes related to Services.

This Privacy Policy applies to all Services related to indaHash Coins distribution event.

### **Who is responsible for the personal information collected on this Website?**

Your personal data is processed ultimately by **IDH MEDIA S.A.** (joint-stock company) with its registered seat in Warsaw at Solec Street 22, 00-410 Warsaw, Poland, entered into the register of entrepreneurs of the National Court Register, maintained by the District Court for the capital city of Warsaw in Warsaw, 12th Commercial Division of the National Court Register, under KRS number 0000586791, NIP (tax identification no.) PL 7010521164, REGON (statistical no.): 363020725, share capital amounting to PLN 112,952.80 (fully paid-in) (hereinafter referred to as the "Company" or "We").

### **Personal information**

"Personal information" is information that can be associated with a specific person and could be used to identify that specific person whether from that data or from that data along with other information that Company has or is likely to have access to.

Any personal information which you volunteer to the Company will be treated with the highest standards of security and confidentiality. Your privacy is important to us. Therefore, we apply various measures, high market standards and use different means to protect your data.

### **Collection and use of personal information**

We collect, process and retain personal information from you and any devices (including mobile devices) you may use when you: use our Services, register for an account with us, provide us information on a web form, update or add information to your account, or dispute resolution, or when you otherwise correspond with us regarding our Services.

The personal information we collect includes the following:

• Computer and connection information such as statistics on your page views, traffic to and from the sites, referral URL, ad data, your IP address, your browsing history and your web log information

**Personal information we collect using cookies, web beacons, and similar technologies**

We use cookies, unique identifiers and similar technologies to collect various information, including your IP (Internet protocol) address, information about the pages you view, how you got there (by search engine or directly). The aim of using cookies and similar technologies is to facilitate your use of our website(s), app(s) and Services (whichever applies). Cookies are important to create statistics and to adjust for your chosen settings. You can always block the cookies in your browser, as well as you can remove them from your device. **Use and retention**

Any time you consider it unuseful or decide to resign from receiving such marketing contents you can freely do so by informing us at least via e-mail.

We retain your personal information as long as it is in the line with applicable laws and necessary and relevant for our operations. In addition, we may retain personal information even from closed accounts to comply with national laws, prevent fraud, collect any fees owed, resolve disputes, troubleshoot problems, assist with any investigation, enforce our Agreement and take other actions permitted or required by applicable national laws. After it is no longer necessary for us to retain your personal information, we dispose of it in a secure manner according to our data retention and deletion policies.

If you discover that We hold inaccurate information about you, you can request the Us to correct that information. Such a request must be in writing or via e-mail.

### **Access**

We will only disclose information under the applicable laws.
